5.3.1 Prep & Wrap proposition

This branch notes that:

There is an increased trend of productions seeking to apply Prep & Wrap to the Camera Department.

Prep & Wrap is not customary in the Camera Department.

The PACT guidance on the TV Drama agreement says that a "crew member's daily rate is deemed to include...a specified amount of time for prep and wrap...as is customary to that department".

The same guidance also says "All departments....should agree a specified amount of prep and wrap in the deal memo."

To comply with both the guidance and the spirit of the TV Drama agreement, therefore, all deal memos for staff in the Camera Department should include a specified time of zero hours and minutes for Prep and Wrap.

On exceptional occasions when longer Prep & Wrap is agreed, the guidance says that it "should always reflect normal industry practice and cover the type of activity typically covered by prep and wrap".

COVID tests, shooting related work, travel, waiting for crew transport etc. cannot therefore be called Prep and Wrap.

Accordingly, this branch requests members to seek to ensure that when their deal memos include Prep and Wrap, the duration of such is zero hours and zero minutes. When exceptionally crew members agree to longer Prep and Wrap, it must only be for their usual prep and wrap type of work.
